## AN ORDINANCE DECLARING ROAD CLOSURES FOR A PARADE

**WHEREAS**, the Town Council of the Town of Holly Springs acknowledges a long tradition of providing an annual Christmas parade for the pleasure of its citizens and the financial benefit of its local businesses; and,

**WHEREAS**, the Town Council realizes a parade requires approximately 90 minutes for the parade to step off, proceed its route and disband and also requires approximately 90 minutes for the removing of signs, traffic control and litter; and

**WHEREAS**, local police have identified and will carry out adequate alternate routes of travel for traffic on roads and streets impacted by the event;

**NOW, THEREFORE, BE IT ORDAINED** by the Town Council of the Town of Holly Springs, pursuant to the authority granted by NCGS 20-169, that it hereby declares a temporary road closure during the day and time set forth below on the following described portions of State Highway System routes:

**Date:** Saturday, Dec. 8, 2018  
**Time:** 10:30 a.m. to 1 p.m.  
**Street(s):** N.C. Hwy. 55 (Main Street) between Cayman Ave. and Ballentine Street and the intersection of Holly Springs Road and N.C. Hwy. 55.


### EFFECTIVE DATE
