ALL BILLS FOR WATER, SEWER, GARBAGE AND RECYCLING SERVICES ARE DUE BY THE 25TH OF THE MONTH. CURRENT FEES ARE AS FOLLOWS: GARBAGE FEE: \$8.15 RECYCLING: \$3.25 YARD WASTE: \$2.00

ALL UTILITY BILLS NOT PAID BY THE DUE DATE INDICATED ON THE BILL, WILL BE ASSESSED A \$5.00 LATE CHARGE. BILLS WHICH REMAIN UNPAID AT THE TIME OF NEXT BILLING ARE SUBJECT TO DISCONNECTION AND ASSESSED A \$25.00 DELINQUENT FEE WHICH MUST BE PAID IN FULL BEFORE RESTORATION OF SERVICE.

IN THE EVENT A WATER METER HAS BEEN TURNED OFF BY THE TOWN AND IS SUBSEQUENTLY FOUND BACK IN SERVICE, THERE WILL BE A FIFTY DOLLAR (\$50) FINE IMPOSED FOR TAMPERING WITH TOWN PROPERTY. WATER METERS ARE TURNED ON AND OFF BY APPROPRIATE TOWN EMPLOYEES ONLY.

THE FOLLOWING DEPOSITS SHALL BE APPLICABLE UNLESS YOU ARE A RESIDENTIAL HOMEOWNER AND CAN PROVIDE THE MOST RECENT TWELVE (12) MONTHS OF PREVIOUS ACCOUNT HISTORY WITH A PUBLIC WATER SUPPLIER WITHOUT LATE PAYMENT OR A LETTER OF CREDIT FROM A PUBLIC WATER SUPPLIER. PLEASE SUBMIT APPLICATION AND CREDIT HISTORY TOGETHER SO THAT YOUR APPLICATION WILL BE PROCESSED PROMPTLY.

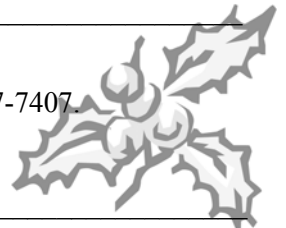
